† It would appear to be S. Read, and might account for the emigration from England to Nova Scotia.

‡ JOHN SCOTT of Amherst Point, county Cumberland, was probably the first of the Scotts to settle in Nova Scotia. He is believed to have died in New York City of yellow fever in 1798. His wife is said to have been Mary Gilmore, daughter of John Gilmore by his wife Mary Stewart, of Stuart. It is possible that he was twice married, and that Mary Gilmore was not the mother of all his children, who were, order of birth uncertain: 1 *Frances Elizabeth Scott* b. 1760; d. in New York City, 18 Oct. 1845; m. (1) Roger Robinson; (2) Joseph Chandler, at Horton, Kings County, Nova Scotia, 12 March, 1799; by her first marriage Francis Elizabeth (Scott) Robinson had: *Mary Robinson*, b. at Halifax 16 Dec., 1790, who took the name of Chandler, and, as *Mary Robinson Chandler*, m. in New York City, 21 July 1805, Aaron Bloodgood, Jr., of New Brunswick, N. J., and died in Philadelphia, Pa., 10 Aug. 1869. 2 *Mary Scott*, m. — Berry, 3 *Martha Scott*, m. — Bensell; had issue. 4 *Robert Hamilton Scott*, b. 1 Feby., 1770; d. 18 June, 1818; was a physician in Albany, N. Y.; said to have removed to New York City in 1813; m. 22 Nov., 1798, Hannah Gildersleeve, b. 15 Nov., 1777; d. 3 Oct., 1814; issue: 1 *James Gildersleeve Scott*, b. 25 Jan., 1799; removed to Virginia. 2 *Marie Gilmore Scott*, b. 12 March, 1801; went to Ohio. 3 *Eliza Ann Scott*, b. 27 April, 1804. 4 *Rodney Robert Scott*, b. 2 May, 1807. 5 *Harriet Amelia Scott*, b. 16 April, 1810, m. I Francis Elizabeth Scott, born 1760, died New York City, October 18, 1845; (I) Roger Robinson (2) Joseph Chandler at Horton, Kings County, Nova Scotia, 12 March 1799; by her first husband Francis, Elizabeth (Scott) Robinson had Mary Robinson, born Halifax 16 December 1790, who took the name of Chandler, and as Mary Robinson Chandler, m. in New York City 21 July 1905, Aaron Bloodgood, Jr., of New Brunswick, New Jersey, and died Philadelphia, Pa., 10 August 1869.
